WHEREAS, Vendor agrees to reserve booth space from Sponsor located at Host's designated ground in Manitowoc, WI. Therefore, the two parties agree as follows:

Deposit money: Deposit money will be held in a non-interest-bearing trust account by Hmong Community Center of Manitowoc County (HCC) and will be mail out to vendor at the end of the event after the booth space is inspected and clear of damage.

Cancellation: If booth space is canceled 14 (two weeks) days prior to event, only deposit will be returned-NO EXCEPTION.

Space usage: If space is not used by 9:00am on Saturday of the event, HCC reserved the right to make change or re-assign booth at its discretion and booth fee will not be REFUND.

Rules and Regulations: Vendors shall apply for permit as required by state or city/county Health Department's rules and regulations. Shall vendor violate any health regulations/requirements and were not permit to sale, there will be NO REFUND except Deposit.

Garbage: Vendors will agree to mark all their garbage bags with stickers provided by sponsors

Damages: The Vendor is responsible for any damage to his/her booth space ground, except for normal wear. If there is substantial damage found, the Vendor is responsible for any repair cost for his/her booth space and the deposit money will be applied toward cost of repair. Vendor is responsible for additional cost of repair if the amount of deposit money is insufficient to cover the damage material or areas. Please inspect your area prior to setting up booth.

Agreement: This contract is only an agreement between the Vendor and the Sponsor for the event on the dates above. This contract replaces and cancels any previous agreements between the Vendor and the Sponsor. Once signed and dated, this contract can only be amended with approval by the Sponsor.
